Expression of Interest

Kendriya Vidyalaya Sangathan (KVS) is an autonomous body setup by the Ministry of Education, Government of India, to establish, administer and manage the Kendriya Vidyalayas spread across India.

Kendriya Vidyalaya Sangathan invites Expression of Interest (EoI) from the Nationalized bank for collection of Quarterly fees from the student from the Financial Year 2024-25 onwards. At present there are 1252 Kendriya Vidyalayas pan India in which approximate 14 lakh students are enrolled under various categories (Gen/SC/ST/OBC/EWS/Single Girl Child etc.).

Kendriya Vidyalaya Sangathan presently has a robust e-system for collection of fees which was build and maintained by a Nationalized bank starting from FY 2014-15. The same is being operated by KVS official at various level.

The salient features in this regard are mentioned below: -

1. Bank will be responsible to design complete software and provide/setup required infrastructure in this regard.
2. The Annual fees to be collected is estimated to around Rs.900.00 Cr. to 950.00 Cr. per annum. Fee to be collected has to be remitted to concerned KV, RO and KVS (HQ) as per specified mandate. The prospective nationalized bank has to provide an automated solution for parking of surplus fund at KV, RO and KVS (HQ) level.
3. The students belong to various category and prospective nationalized bank has to build and maintain a robust system which will be executed at Vidyalaya level, Regional Office level and KVS (HQ) level.
4. Fee to be collected from the students by all e-modes presently available i.e. Debit Card/Credit Card/ UPI, Net Banking and other e-modes available, in addition to Physical mode of challan in the concerned bank branch.

5. The prospective nationalized bank if interested will be required to participate in bid process comprising of technical and financial bid. A separate Request for Proposal (RFP) will be issued later on for this purpose.
6. The Expression of Interest (EoI) has to be submitted in the specific format as enclosed at **Joint Commissioner (Fin.), Room No.1 Kendriya Vidyalaya Sangathan (HQ), 18 Institutional Area, Shaheed Jeet Singh Marg, New Delhi-110016 by 05.00 P.M. of 02.01.2024.** The Expression of Interest in the specified format will not be entertained through email.
